RESOLUTION 13 OSPA/05/2023

**RESOLUTION ON MECHANISMS FOR EFFECTIVE IMPLEMENTATION OF THE
RESOLUTIONS AND RECOMMENDATIONS OF THE FP-ICGLR,**

- **Pursuant** to the spirit that presided over the materialization of the resolutions and recommendations of the FP-ICGLR;
- **Recognizing** the commitment to implement the Pact on Security, Stability and Development in the Great Lakes Region signed on December 15, 2006 in Nairobi, Republic of Kenya;
- **Whereas** the provisions of the Articles 2 and 6 of the Inter-Parliamentary Accord establishing the Forum of Parliaments of Member States of the International Conference on the Great Lakes Region signed on December 4, 2008 in Kigali, Republic of Rwanda;
- **Confirming** the commitment of the FP-ICGLR to strengthen the mechanism for implementing the resolutions and recommendations adopted by the Plenary Assembly of the FP-ICGLR;

Adopts the following resolutions:

1. **Urges** the Governments of the ICGLR-Member States to effectively implement and concretize the resolutions and the recommendations made by the FP-ICGLR;
2. **Calls upon** the National Parliaments of the ICGLR-Member States to continue to:
 - a) Utilise their political and democratic legitimacy to engage in the implementation of the resolutions and recommendations adopted by the FP-ICGLR Plenary Assembly;
 - b) Provide regular feedback on the status of the implementation of the resolutions and recommendations in their respective ICGLR Member States;
3. **Requests** the General Secretariat of the FP-ICGLR, for a better implementation of the resolutions and recommendations, to:

- a) Disseminate all adopted resolutions and recommendations to National Parliaments and others institutions and organisations responsible with their implementation;
 - b) Publish the resolutions and recommendations of the FP-ICGLR on its website to allow its partners to consult and download the said documents;
 - c) Heighten its vigilance in the implementation of the resolutions and recommendations adopted by the FP-ICGLR, while carrying out monitoring and evaluation;
 - d) Collaborate, through the National Parliaments of the ICGLR Member States, with the heads of the institutions responsible of the implementation of the said resolutions and recommendations on the status of the implementation, the encountered difficulties and the future prospects;
4. **Welcomes** the initiatives of the National Parliaments to accept and support the mechanism for the materialization of the resolutions and recommendations adopted by the PF-ICGLR as well as to promote the sharing of information on the progress of their implementation;
 5. **Requests** the Secretary General to monitor the materialization of the resolutions and recommendations adopted by the FP-ICGLR and to report thereon to the next session of the Plenary Assembly;
 6. Decides to remain actively seized by the implementation of the resolutions and recommendations adopted by the various sessions of the Plenary Assembly of the FP-ICGLR.
